Currently, 78.0% of the 2,451 housing units in the area are owner occupied; 14.3%, renter occupied; and 7.8% are vacant. Currently, in the U.S., 56.4% of the housing units in the area are owner occupied; 32.4% are renter occupied; and 11.2% are vacant. In 2010, there were 2,323 housing units in the area - 73.8% owner occupied, 21.0% renter occupied, and 5.2% vacant. The annual rate of change in housing units since 2010 is 2.41%. Median home value in the area is \$155,908, compared to a median home value of \$234,154 for the U.S. In five years, median value is projected to change by 4.41% annually to \$193,426.
