Currently, 84.7% of the 1,462 housing units in the area are owner occupied; 8.3%, renter occupied; and 7.0% are vacant. Currently, in the U.S., 56.4% of the housing units in the area are owner occupied; 32.4% are renter occupied; and 11.2% are vacant. In 2010, there were 1,354 housing units in the area - 88.8% owner occupied, 6.9% renter occupied, and 4.4% vacant. The annual rate of change in housing units since 2010 is 3.47%. Median home value in the area is \$263,161, compared to a median home value of \$234,154 for the U.S. In five years, median value is projected to change by 1.48% annually to \$283,183.
